

Rodeo Sanitary District

Contractors with a valid Class A – General Engineering; Class C-34 – Pipeline Contractor; or Class C-42 – Sanitation System Contractor license are invited to bid construction of the CWWMP Sewer Year 3B Improvements in Rodeo, CA, for the Rodeo Sanitary District. The Project consists of installation of approximately 3,424 linear feet of new or replacement sewers ranging from 6 inches to 8 inches in diameter. The sewer work will include pipe bursting rehabilitation of approximately 1,468 linear feet of 6-inch diameter VCP sewer with 6-inch diameter HDPE SDR-17 pipe; open-cut replacement of approximately 1,615 linear feet of 6, 8 and 10-inch VCP or PVC or HDPE sewer with 6 and 8-inch diameter PVC SDR-26 or HDPE SDR-17 sewer; open cut installation of approximately 341 linear feet of 6 and 8-inch PVC SDR-26 sewer; open cut installation of approximately 245 linear feet of new building sewer extensions; replacement of 15 existing manholes with new manholes; installation of 4 new manholes; rechanneling of 2 existing manholes, replacement and or reconnection of approximately 78 building laterals; abandonment of approximately 478 linear feet of 4, 6, 8 and 10-inch VCP and PVC sewer; traffic control, SWPPP requirements, and miscellaneous surface restoration work. The Engineer's opinion of probable construction cost is \$1.26 million.

The project will be funded by the California Clean Water State Revolving Fund (CWSRF). A financing agreement has been issued by the CWSRF and the contract award can be made on this project when the bid is accepted by the District Board of Directors. The project will require compliance relative to utilization of DBE, including the Six Good Faith Efforts (GFE) listed in the appendix of the specifications prior to bid opening. Contractor shall submit EPA Form 6100-3 DBE Subcontractor Performance Form, EPA Form 6100-4 DBE Subcontractor Utilization Form and any required attachments with the bid.
