

RODEO SANITARY DISTRICT NOTICE OF PUBLIC HEARINGS (1) ON INTENT TO COLLECT FISCAL YEAR 2021-2022 SEWER SERVICE CHARGES ON COUNTY TAX ROLL AND THE FILING OF REPORT UNDER SECTIONS 5470-5475.10 OF THE HEALTH AND SAFETY CODE OF THE STATE OF CALIFORNIA, AND (2) TO COLLECT DELINQUENT SOLID WASTE COLLECTION CHARGES BY PLACING LIENS UPON THE PROPERTIES THAT RECEIVED THE COLLECTION SERVICES AND ON THE COUNTY'S PROPERTY TAX ROLL AND (3) TO COLLECT DELINQUENT SEWER SERVICE FEE CHARGES BY PLACING LIENS UPON THE PROPERTIES THAT RECEIVED THE SEWER SERVICE AND ON THE COUNTY'S PROPERTY TAX ROLL.

NOTICE IS HEREBY GIVEN THAT: The Board of Directors of the Rodeo Sanitary District will hold three public hearings during its regular meeting on Tuesday, August 10, 2021 at 1:00 p.m. Pursuant to State of California Executive Order N-25-20, the meeting will be held by video-teleconference via the Zoom webinar application. Please see forthcoming agenda at <https://www.rodeosan.org> for the August 10, 2021 Regular Board Meeting, which describes how to attend the meeting and to submit comments.

These public hearings are being held to enable the Board to consider the following matters: 1. Placing the Fiscal Year 2021-2022 Sewer Service Charges on the Contra Costa County tax roll for collection by enacting an Ordinance establishing the Fiscal Year 2021-22 Sewer Service Charges, and adopting a report listing each property and its respective charge, and by enacting the draft Resolution 2021-03 directing collection of the charges on the Contra Costa County tax rolls. 2. Directing that delinquent Solid Waste Collection charges be collected by placing liens upon the properties that received the collection services and on the County's property tax roll, by enacting Resolution 2021-04. 3. Directing that delinquent Sewer Service Fees be collected by placing liens upon the properties that received sewer services and on the County's property tax roll, by enacting Resolution 2021-05.

The report listing each property and its respective Sewer Service Charges, and the proposed ordinance and the proposed resolution concerning the Sewer Service Charges, are each available upon request. A report listing each property and its respective delinquent Solid Waste Collection charges and Sewer Service Fee charges, is available upon request.

Written comments may be submitted to the Rodeo Sanitary District on either or both matters prior to the hearing date or on the hearing date before the conclusion of the public hearing.
