ORDINANCE NO. 2022-200

AN ORDINANCE ESTABLISHING A REVISED CALCULATION METHOD FOR SEWER SERVICE CHARGES TO BE BILLED BY THE RODEO SANITARY DISTRICT TO MIXED RESIDENTIAL AND COMMERCIAL USERS SHARING ONE WATER METER

THE DISTRICT BOARD OF RODEO SANITARY DISTRICT HEREBY FINDS, DETERMINES, AND DECLARES AS FOLLOWS:

WHEREAS, the Rodeo Sanitary District (District) has reviewed and instituted a sewer service charge program compatible with the Clean Water Act to finance the yearly operation and maintenance of the District's sewage collection, conveyance, treatment, and disposal system; and

WHEREAS, the Rodeo Sanitary District is required by State law and policy to collect revenue sufficient to cover the cost of operating these systems; and

WHEREAS, on September 26, 2022, and October 3, 2022, the Notice of the Public Hearing to Consider the revision to the sewer service fee calculation for mixed residential and commercial users serviced by a single water meter, was published in accordance with Health and Safety Code section 5473.1 and Government Code section 6066 in a paper of general circulation and posted on September 26, 2022, in three places within the District; and

WHEREAS, on October 11, 2022, the Board conducted the public hearing on the proposed revision to the sewer service fee calculation for mixed residential and commercial users sharing one meter pursuant to the notices described above prior to the enactment of this Ordinance; and

WHEREAS, in accordance with Ordinance 2018-100, this Ordinance changes the calculation method for certain sewer service fee categories and charges; and

WHEREAS, in accordance with Proposition 218, all applicable notification and procedural requirements were satisfied; and

WHEREAS, the Board of Directors of the Rodeo Sanitary District has reviewed the proposed revision to the present sewer service charge calculation method for mixed use customers and has determined that the proposed calculation method for mixed use customer would better reflect the users' respective burdens on the overall sewer systems, and therefore should result in more proportionate charges for mixed use customers; and

THEREFORE, BE IT ORDAINED by the Board of Directors of the Rodeo Sanitary District as follows:

1. The annual sewer service charges (rates) for residential customers shall be unchanged from Ordinance 2018-100.

2. The annual sewer service charges (rates) for commercial customers shall be unchanged from Ordinance 2018-100. The paragraph appearing beneath the table of Commercial Rates in Section 2 of Ordinance 2018-100 shall be superseded by the following text:

"Commercial sewer service charges shall be based on water meter reading or minimum charge, whichever is greater, and will be billed annually.

For multiple user types serviced by a single water meter, customers will pay a proportionate charge based on their water use, the square footage they occupy, and the relative strength of the wastewater as set forth in the flow factors in Exhibit A. The minimum charge is equivalent to one residential unit. To determine the charges for mixed residential commercial or mixed commercial users, the floor area for each customer, water use, and calculated flow factor will be used. Example calculations are presented in Exhibit B."

- 3. The Board of Directors independently finds that this action is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15273 (a) (1), (3), and (4) of the State CEQA guidelines because these rates are being established for the purpose of meeting operating expenses necessary to maintain service within the existing service area.
- 4. This ordinance shall, pursuant to Health and Safety Code section 6490, be published once in the <u>West County Times</u>, a newspaper of general circulation, and circulated within the Rodeo Sanitary District, and shall be effective October 12, 2022, at which time the portion of Ordinance 2018-100 referenced above in section 2 above shall be superseded. The remainder of Ordinance 2018-100 shall remain in full force and effect.
